### My Thoughts - Academic Regalia

In 2008, the ACLM leadership requested that I research academic regalia for our College. At that time. I interviewed physician executives from The American College of Surgeons, The American College of Physicians, The American College of

Cardiology, and The American College of Obstetrics and Gynecology. I joined <a href="The Burgon Society">The Burgon Society</a> – "the learned society for study of academical dress and regalia – design, history and practice around the world", which is registered in England & Wales. I purchased numerous books and treatises on the subject and spoke with representatives of the Inter-Collegiate Code, which dictates the uniform standards of American academic regalia.

I am proud to share that during the 2023 Mid-year Board Meeting, the Board of Governors approved the official ACLM academic regalia I designed for the Fellows, President, and Past Presidents. During the 2024 San Diego Conference, the Board of Governors will don this academic regalia during the ceremonial induction of new ACLM Fellows. Tradition will be established. Additionally, I encourage any ACLM Fellow to order their own official ACLM academic regalia to wear during these ACLM induction ceremonies or during other academic ceremonies. When I am invited to speak at convocations or commencement ceremonies, I choose my Brown Medical School regalia for medical school or public health school ceremonies. For law school ceremonies, I wear my St. John's University School of Law regalia. Now all of us have the opportunity to display our dual fields with the ACLM regalia. It is my hope that the regalia initiates discussion among our peers and further cements our presence in academia.

Please note that the Fellow's regalia is different from the Presidential regalia and the Beefeater cap is only for the Presidential regalia. Therefore, interested Fellows should order the eight - sided Tam. They should also order their hood from the drop-down list (i.e. Medicine - Hunter Green, Dentistry - Lilac, Pharmacology - Gold and Podiatry – Olive/Nile green). Also, keep in mind that it may take up to eight (8) weeks to receive your regalia.
